The Animal Fancier License allows one (1) additional dog or cat, over the age of five (5) months, to reside at a property zoned Low Density Residential (R-1), Low Medium Density Residential (R-2), or in a detached single-family dwelling, twinhome or duplex for a maximum of five (5) animals. Animal Fancier licenses are not allowed for units of three (3) or more or in mobile home communities. No Owner shall have more than four (4) dogs or four (4) cats.

_____	I have read the provisions of the Onalaska Code of Ordinances Section 7.04.11.D.3 with reference to the Animal Fancier License.

_____	I understand that in the event of a complaint to confirm compliance with the permit requirements, the City has jurisdiction to inspect those parts of the premises where animals are kept.
_____	I agree, in consideration of the granting of this license, to comply with the laws of the State of Wisconsin, and the provisions of the Municipal Code of Ordinances of the City of Onalaska.
