

PUBLIC NOTICE TO ALL CUSTOMERS OF THE ONALASKA MUNICIPAL WATER UTILITY

The Onalaska Municipal Water Utility has filed an application with the Public Service Commission of Wisconsin (PSCW) to increase water rates. The increase is necessary due to a 35.18 percent increase in gross plant investment and a 41.28 percent increase in operating expenses since the last water rate case was completed in 2015.

If the request is granted, the increase in water rates will be implemented in two steps. The increase in Step I is estimated to be \$746,951. The Step II increase of the remaining \$164,711 would be implemented when the booster station authorized by the PSCW in docket 4410-CW-109 and the new reservoir authorized by the Commission in docket 4410-CW-110 are completed and placed into service. Therefore, the overall increase is \$911,662, or 39.65%.

If the request is granted, the water bill for an average residential customer with a 5/8-inch or 3/4-inch meter who uses 2,000 cubic feet of water quarterly will increase from \$49.47 to \$67.95, or 37.36% (including the public fire protection charge), in Step I. Bills for the same customer will increase from \$67.95 to \$72.10, or 6.11% (including the public fire protection charge), in Step II. Therefore, the customer's overall bill will rise approximately 45.74% (including public fire protection), after Step II has been implemented.

A telephonic public hearing on the application has been scheduled for Friday, October 16, 2020, at 10:00 a.m. This virtual hearing has no physical location. This is a virtual hearing to which members of the public may attend by telephone or listen to live broadcast on-line.
